NOTIFICATION

Accordingly, the said category of institutions will be made disabled on the "DARPAN" portal to restrict all such institutions from admission.

In this regard, it is to bring to the notice of all such institutions about this office letters issued to the institutions vide No- AHSEC /R&A /ADMN /2020 /03 /01/ 7710 dated 14<sup>th</sup> June, 2022 and vide No- AHSEC/ R&A/ ADMN/ 2020/ 03/ 01/ 264 dated 02<sup>nd</sup> May, 2023. However, in the case of non-permitted private institutions which have applied for the permission with relevant records in the office of the AHSEC, the records of those institutions will be verified and may be allowed to conduct admission, if the relevant records are found in order.
