This is to inform all the concerned Head of Institutions that the online admission portal "DARPAN" will be live from **01/04/2025 to 08/04/2025**, for registration of new institutions and updating the institution profile by the registered institutions.

As such, all such Institutions registered on "DARPAN" portal are directed to visit [www.darpan.ahseconline.in](http://www.darpan.ahseconline.in) or [www.ahsec.assam.gov.in](http://www.ahsec.assam.gov.in) to update their institution profile using their existing login credentials from **01/04/2025 to 08/04/2025**, in order to process the Admission of students into HS 1<sup>st</sup> Year Class for the session 2025-26.

However, those institutions which have recently obtained Academic Permission from ASSEB, DIV-II but have not yet registered on the "DARPAN" portal are directed to register their institution using token number which will be shared with Principal through SMS in order to create institution profile and conducting admissions for the session 2025-26 accordingly.

The "DARPAN" portal for admission in Class XI for the session 2025-26 will be opened within 3 days after declaration of results of HSLC Examination. Accordingly, classes of HS 1<sup>st</sup> Year for session 2025-26 will commence from 2<sup>nd</sup> May, 2025.

**Further, Offline admission shall not be entertained under any circumstances.**

**Note: At the time of profile update/New registration, UDISE code in case of HS/Sr. Sec. Schools and AISHE Code in case of Degree Colleges is mandatory.**
